

## PAPER MART 2018 CRAFT CHALLENGE TERMS & CONDITIONS

1. NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

The coupon code will be delivered via email to each winner. Prizes may not be exchanged or returned for any monetary amount.
